COMMUNITY AND SOCIAL WORKING GROUP

The Working Group is now well and truly up and running and has two events planned to bring people together for some good, inexpensive fun.

Sunday 29 June – Some Liverpool Delights! - A coach will leave Curzon Park at 10.30 am and travel first to <u>Sudley House Museum in Mossley Hill - the former home of 19th century Liverpool Shipping magnates, George Holt (aka Onedin), and contains fine displays of momenti from his travels to the Orient as well as his art collection, including Gainsborough, Reynolds, Landseer and Turner. At the time of our visit, there'll also be a large photographic exhibition of the palaces some of the local 19th century merchants built for themselves. The less intrigued among us (guaranteed to be few) can take advantage of an excellent tea and coffee shop.</u>

Being limited to 49 seats on the coach, it's first come, first served (cash or cheque). Regrettably, we will not be able to take non-residents of Curzon Park unless there are seats otherwise unsold. HIGHWAYS AND OPEN SPACES WORKING GROUP

Advertising Hoardings: 8 Curzon Park South - The CPRA advised CPS residents that a retrospective planning application had been submitted Morris Developments by hoarding/advertising signage at No 8 CPS. 24 residents responded independently and the application was refused. Morris Developments have now been issued with a Section I6 notice and the matter will pass to solicitors and legal proceedings will be processed (eventually!). They can revisit the Planning Department and consult with them regarding an alternative arrangement, which they may well do at some future date.



We remain concerned that advertising of this nature within the Conservation Area is totally inappropriate and could be in-situ for a number of years as a result of the sluggish housing market and saturation of flat developments in the city. However, everything is being done that can be and your support through writing individual letters has been instrumental in achieving the desired initial outcome of rejection.

Grass Verges - The grass verges, the kerbstones and pavements throughout Curzon Park are in poor condition and there are many issues to address in the foreseeable future. The situation is not helped when vehicles are parked illegally on the verges. The Community Police Officer has issued numerous parking tickets in the area and assures us he is monitoring the situation, which to be fair has improved.

With regard to the verges churned up regularly as a direct result of No 8 CPS flats development, Cheshire County Council's Highways Engineer says the contractor will rectify the damage caused around this area and the remaining verges will be reinstated by the Council when conditions improve. The delay in completing this is due to changes being made to the kerb line in

order to widen the entrance to the new properties at No 8 CPS.

Additionally, there has been damage to the roots of the large tree adjacent to the entrance to number 8. From a safety viewpoint the preferred option is to fell and replace the tree. The Tree Officer has insisted on a minimum 45 cm girth replacement tree of the same type and although the felling will take place imminently, the replacement may have to wait until the autumn, availability being a major consideration.

Ongoing Monitoring of Highways/Open Spaces' Issues - In order to monitor issues on an ongoing basis with the objective of maintaining and improving standards within the area, it would be beneficial to have one nominated member from each road within Curzon Park who is willing to be contacted from time to time and to act as a liaison point. Trees - The trees in the Curzon Park Conservation Area are protected, both in private gardens and open spaces. Currently Cheshire County Council Highways have responsibility for managing **all** the trees within the curtilage of the highway within Curzon Park.





After concerns were expressed about the condition and maintenance of the trees, members of the Working Party met with the County Council Tree Officer on 22 May who generously gave us two hours of his time and knowledge whilst inspecting the condition of the trees. We established that a number of young (reasonably newly planted) trees were in dire need of attention. Some had outgrown their protective cages, some cages had caused irreversible damage to the trunk and many had considerable growth on the lower trunks impeding growth. Significantly, some trees are being so seriously damaged by negligent contractors mowing and strimming the verges that a number will have to be removed in CPN, Earlsway and Park Road West. The County Council is currently in consultation with the private contractors.

We also conveyed that in some cases the selection of species used for planting, has been inappropriate - e.g. there is a number of the cherry (prunus) variety in an area of predominantly Horse Chestnut trees and we were keen to keep to some uniformity of the street scene. The tree officer agreed that some inappropriate planting had taken place and replacements are necessary.

A number of lime trees were identified which had very extensive growth around the bases. Although this is considered 'normal' and not detrimental to the health of the trees, they would eventually impede the footway and will require pruning. Likewise some trees on the entrance to CPN were identified as about to cause an obstruction, however some of these are in private gardens.

The 'new/young' trees in CP require immediate remedial attention, i.e. simple housekeeping which is very achievable, as currently *public money is being wasted* by not maintaining them. Both the City Council and County Council will be advised of our concerns.

Giant Hogweed

A number of Curzon Park North residents recently found Giant Hogweed encroaching into their gardens from the river bank. A representative of the Association contacted the council, which readily sent a team to eradicate this dangerous weed. However, the association has been informed by a council official that the problem will continue to arise, due to a very large infestation in a field near to the river and the Grosvenor Bridge. The Council have written to the owner pointing out the infestation and its possible consequences to health, but they have no rights of enforcement and therefore can do no more. At the time of writing, the owner appears to have taken no action.

RACECOURSE ISSUES WORKING GROUP

The Chester Race Company's Premises Licence – Development of new facilities at the racecourse, required the Race Company to apply for a new premises licence at the beginning of 2008. The application as submitted sought considerable freedom to mount activities at unsociable hours, threatening frequent and significant disturbance to Curzon Park residents, primarily from noise. CPRA, working with a group

of Nuns Road residents, worked to negotiate modifications to the application, and arranged legal representation at the licence application hearing held on 8th April.

The previous main cause of complaint had been late night noise from events in marquees involving live and recorded music. The use of the Temporary Event Notice (TEN) procedure had allowed the Race Company to circumvent restrictions on licensed hours to hold events until 1.00 a.m. or later. Unfortunately, the legislation did not allow the licensing authority to prevent the use of TENS, but it included in its decision a recommendation that the procedure should not in future be used as a way round the licence restrictions. While refusing to agree not to use marguees, they have stated in writing that they plan, in future, to use the owners' and trainers' pavilion for the sort of event for which they have previously used them.

The Champagne Garden – The original application would have allowed late night music and drinking in this area, which is close to the Golf Club end of Curzon Park North. In any event, the authority placed a 9.00 p.m. deadline on any entertainment in this area.

New Year's Eve – The application would have allowed revelries both inside and outside racecourse buildings throughout the night from New Year's Eve until New Year's Day. The Race Company has given a written assurance that there will be no external activity apart from the setting off of fireworks at midnight.

3-day Pop Concert – Unfortunately for those who object to it, this was allowed without specific restrictions, although the Race Company has stated in writing that it would not hold the event other than at a weekend and would close it by 2230 on any relevant evening. No event is planned for 2008.

Noise generally – The licence granted imposes specific technically-expressed restrictions on the noise levels that are permissible during "regulated" (licensed) activity. The Company is required to monitor them at all "regulated" events, except on race days, and to keep records.

"Non-regulated activities" – Some residents have expressed concern about disturbance from amplified announcements and commentaries during events such as the kite festival and polo matches. Unfortunately, these are not "regulated" activities and therefore outside the jurisdiction of the licensing authority Residents should know,

however, that the Roodee remains the property of the City Council and that the Council has legal obligations to prevent nuisance to neighbouring occupiers. CPRA will take up with the Council any unreasonable use of the Roodee, whether from a "regulated activity or not.

Control over the Race Company's activities and complaints

The authority imposed conditions in the licence, requiring the Race Company to have a written complaints procedure. They have now published this, as follows:

Additionally, the Race Company will, by email, provide a quarterly list of upcoming events to anyone registering an interest. The email address to use to request this information is as above.

COMMUNITY SAFETY WORKING GROUP

Members of the Community Safety Working Group, along with other interested residents, attended the recent <u>Police</u> 'Community Action Meeting' [CAM] at Chester Golf Club. The local Police Community Support Officers [Kevin Griffiths and Ian Hardy] advised residents to report all incidents to the Police including minor damage to cars. When reporting incidents, the Police find it helpful to have the following information:

- Nature of problem
- Location
- Description of culprits [eg number of persons, approx age, colour of clothing]
- Direction in which they have run off

Youngsters are now hiding away from the Police to drink alcohol. If you see alcohol being passed on to young people [eg outside off-licences], you should notify the Police. If they get a report of under-age drinking, the Police will follow it up.

The next meeting of the Police Community Action Team is scheduled for Monday 4 August.
