HIGHWAYS & OPEN SPACES

Lamp Post Maintenance

All lamp posts are now the responsibility of the 'new' authority (including those in Dingle Bank), numbered and administered via Highways at Guilden Sutton. The entrance to the area has been enhanced by some repainting where lichen has been removed and *delicious* shiny black paint applied.

The leaves are about to fall in CP...

We have liaised with the Council and 'cleansing' (i.e. road sweeping) in relation to leaves will take place on Fridays. We are advised that additional manpower will be provided when the leaves become particularly bad. We discussed the possibility of using cones (in parking bays) on the highway in order to do a 'thorough' job uninhibited by parked cars, and we are advised that this may be possible and implemented.

The Council have requested that Curzon Park residents who sweep the leaves outside their properties should leave the piles on the edge of the verge/roadside for collection, and avoid causing obstruction on either the road or the footway (which could be inherently dangerous to pedestrians).

Residents should also be aware that the mechanical sweeper may be called away from Curzon Park at any time to attend such incidents as Road Traffic Accidents and spillage clean ups etc.

Wheelie Bins

A resident who recently had a hip operation has had trouble negotiating the new wheelie bins on the footway and confirms that this

might affect others who are partially sighted, parents with pushchairs, etc. Barry Davies, Council Officer (Waste Management) will be asking contractors to



replace bins (after emptying) on the edge of drives <u>within</u> the boundary of properties, and will be carrying out spot checks to ensure this is happening. Residents are requested to leave their bins either at the edge of their properties (within the boundary) or, if this is not convenient, on the grass verge, but not on the footpath.

Additionally, **overhanging vegetation** and overgrown hedges can be a real hazard for our neighbours.
