# COMMUNITY SAFETY

Geoff Brown, Chairman of CPRA, has recently written to the Chief Constable, other senior officers and local members of the Cheshire Police Authority thanking the Police for their prompt response to the recent burglaries [someone was arrested and charged with two offences of burglary in the area]. He also expressed appreciation for the work of PCSO Christopher Fox and the effect this has on the local community, giving 'value for money', and the importance of retaining a dedicated PCSO service in Curzon Park.

#### POLICE ADVICE FOR GOING AWAY

 Make your home look like someone is living in it. Don't close your curtains in the daytime; this shows the house is

- empty. Use automatic timer-switches to turn lights on when it goes dark.
- Cancel any milk or newspaper deliveries.
- Avoid discussing holiday plans where strangers may hear details of your absence from home.
- Cut the lawn before you go and trim back any plants that burglars could hide behind.
- Uncollected mail is a sign that you are away. The Royal Mail's 'Keepsafe' service will keep your mail for up to two months while you are away.
- Consider leaving important documents and valuable items with other family members, in your bank or lock them in a safe
- Do not put your home address on your luggage when travelling to your holiday destination.
- If you normally leave valuable pedal cycles or similar items in your shed, consider putting them in the house.

## Help from neighbours

It's a good idea to get help from your neighbours. You could ask them to collect post, sweep up leaves, mow the lawn, open and close curtains, and so on. They could even occasionally park their cars on your driveway. Anything to make the place look lived in. You can repay the favour by doing the same for them. Warn your neighbours not to put your surname, address or even your house number on your keys in case they fall into the wrong hands. Let your neighbours know when you will be away and, if possible, give them your contact details so they can contact you, or someone who can act on your behalf, in case of an emergency

# HIGHWAYS & OPEN SPACES

#### **OVERLEIGH ROUNDABOUT TREES**

Concern was expressed over the removal of trees as we consider this to be a very important visual space for Chester. Councillors have been requested to ensure replacement in the 'growing season' with suitable specimens provided with a specified

maintenance programme to protect taxpayer's investment. Experience of local management of trees allows us to know that sometimes this gets forgotten. We have received an assurance from Councillor Sullivan that he 'will keep these under review when the longer term plans are being finalised'.

#### CHESTER RACECOURSE

Residents concerns have been registered regarding unacceptable levels of noise emanating from recent events - particularly the early June International Polo meeting. You may recall that the Racecourse application for a grant of a new license was approved in April 2008 subject to certain conditions imposed over the performance of live and recorded music. These conditions restrict the time that events can run-on to in the evening and the level of permitted noise. Our understanding is that, unfortunately, amplified voice commentary is not similarly controlled within the terms of the License.

The recent 'Chester Rocks' weekend event on 2<sup>nd</sup> and 3<sup>r</sup> July, had raised some early concerns regarding security, parking and noise problems. It would seem sensible that we continue to monitor our position to prevent any recurrence of past excesses. The most useful feedback residents could provide (preferably by email or letter and photographs) would be to document the date and time of any unacceptable occurrence and the impact on you/your family (plus the distance you are from the Racecourse would be helpful). Hopefully, the fears expressed have been allayed, however the more detailed the feedback the more powerful and cohesive an approach can be made for future representations by CPRA.
