WALKING GROUP

The first three outings of 2012 are planned to be as follows:

Saturday 4th February - Gresford. Meet at 10.30 am at the car park off Gresford High Street by the pond. This is a fairly flat walk with a few small hills around the Gresford area. It will take two hours or a little more, and there will be a chance to have lunch afterwards at the Pant Yr Ochain Hall Hotel.

<u>Saturday 3rd March - South Wirral.</u> Meet at <u>10.20 am</u> at Hooton Station (10.01 am train from Chester or 80p for the Station car park). The walking is generally flat and easy and will take about two hours. Refreshments will be at the Hooton Hotel.

<u>Sunday 1st April – Aldford</u>. Meet at <u>11.30</u> <u>am.</u> at Eccleston ferry car park (Drive through Eccleston and follow the road down to the river). This is a flat walk along the banks of the river Dee to Aldford with a stop at The Grosvenor Arms for refreshments. We then return along the same route. There is one set of steps but otherwise the path is fairly easy although it can be muddy. It takes about one hour to walk in each direction.

Also, according to Cheshire Police, most thefts from motor vehicles could easily be avoided if we take two basic precautions:

- Make sure there are no valuable objects left on view inside your vehicle. Check your vehicle as you leave for handbags, wallets, phones, and sat-nav devices left on display.
- Lock your vehicle securely! Many reported thefts occur from insecure vehicles, which gives the thief the chance to steal from you with the minimum of effort and noise.

FIREWORK EVENING IN CURZON PARK (Nov 5)



Our PCSO, Christopher Fox, single-handedly policed the entire area requesting car owners to park responsibly. He personally placed cones along

areas of CPN and CPS to allow passing points for drivers, which prevented the gridlock of last year and the verges becoming akin to a dual carriageway. Unfortunately, Parking Services failed to 'turn-up' and assist despite prior requests for their involvement. This resulted in some antisocial parking in the area with a number of cars parked on the verges and on double yellow lines. The sheer volume of cars entering the area over a two-hour period was staggering. Without Christopher Fox's input, the next day would inevitably have uncovered substantial verge damage.

We have written to our Councillors requesting that adequate controls are put in place for future events such as these and that the active participation of Parking Services is ensured in order to protect our residential area.

A BIG THANK YOU

To all residents who are adhering to our plea to preserve our verges (previous Newsletter) by advising relatives, friends and workmen of the best way of parking in the road to avoid decimating the verges, particularly when they are most vulnerable. We have received supportive emails to the effect that many residents are doing just that!

BLUE TITS

We reported that perhaps the blue tit is 'flying to the defence of the trees' and may help prevent the leaf minor affecting our horse chestnut trees. The Tree Department of Cheshire West and Chester Council read our article and offered us six blue tit boxes. Watch out for the 'installation team' placing these in our trees!
