STONE BENCHMARK CURZON PARK SOUTH



For many months we have been seeking detailed information as to the extent and

timescales for the necessary repair to the bridge. We have been concerned that the bridge may well be closed for a substantially longer period than the six months as currently advised. We were disappointed to learn that a 'condition' report will not take place until mid/late April and presume any necessary works may follow considerably later. We will continue to facilitate further information but feel it may be relevant for you to share your concerns/views over this, so please assess the potential benefit of making personal representation (with a copy to CPRA) to your local councillors (details in contact box on back page).




We also made reference to the poor standard of maintenance to parts of the Mount Pleasant footpath and will continue to monitor this issue.

FORTHCOMING EVENTS AT CHESTER RACECOURSE

Following recent press releases, most Curzon Park residents will be aware that there are two forthcoming public events

using live and recorded music as well as a public address system. These are beyond the usual racing and event programme.

The first will be the Olympic Torch Celebration on Tuesday 29 May, where the racecourse will be the venue for the activities and the site opens to the public from 16.00 culminating in a firework display at 22.00. The second will be the Chester Rocks weekend programme 16 and 17 June.

Both events will attract large numbers of visitors, and there will likely be some environmental impact on Curzon Park by way of noise pollution and parking.

Just so residents are aware, both events are constrained within the Racecourse licensing arrangements. These arrangements cover both maximum allowable sound amplification levels and the length of time events are permitted to take place. Both these licensing permissions will be monitored by the CW&C Environmental team.

Our local Police Community Support Officer, Christopher Fox, will also be involved in the local planning arrangements to ensure the smooth running of traffic around the neighbourhood during these events.

The CPRA Highways & Open Spaces group has also arranged a meeting with the Racecourse. The prime purpose of this is to look at some of the detail of the impact on our neighbourhood so that we can help structure peoples' expectations over what will be a very busy weekend. It will also give an opportunity for the CPRA to remind the Racecourse of areas that led to complaint in 2011. We expect to be in a position to let residents have a contact point/person at the Racecourse in the event of any significant noise nuisance. However, we trust that this will not be required.
