HIGHWAYS & OPEN SPACES

RAILWAY FOOTBRIDGE

We have recently been informed by our local Councillors that the matter is entirely in the hands of Network Rail who are currently investigating the slippage and foundation problems associated with the bridge structure. We have expressed our dismay at the length of time this is taking and the huge inconvenience to so many people, which is acknowledged. We are also informed that rail passenger transport on this line may be affected for a short time. We will continue to monitor progress.

We are also concerned at the 'permanent' flooding on the roadway entrance to the golf club, which could be a blocked drain and may be a health hazard. This problem has been reported many times with seemingly no action taken. Residents using this only access to the golf club are encouraged to complain to the council about this flooding problem, which is particularly bad after heavy rain. The Golf Club will also be asked to support this complaint.

VERGES

The recent grass cutting and drier weather has made a huge difference to the general appearance of our verges. Vehicular damage is still evident in many places and perhaps, in this respect, all residents could assume responsibility for the appearance of their respective driveway entrances. The Councilors will be considering the erection of "No Parking on Grass Verge" signs in the area. The Green has had its first cut, the daffodils are in full bloom creating a splendid Spring picture.

TREES

Meetings have been held with the Principal Tree Officer of Streetscene, the department responsible for the maintenance and replacement of trees in Curzon Park. We will be requesting some replacement trees this year. Some dead trees have been removed and we have stressed the importance of adequate protection from vandalism for the new young replacement specimens.

It was reported that the deadline date for comments etc. in respect of the current application for a 'Practice Area' on the field adjacent to River Lane had been extended to April 15th.

MORRIS HOMES

Residents will hopefully have noticed that the large Hoarding Board advertisement for Curzon House, which has dominated the Curzon Park South 'skyline' for far too long, has finally been removed. The small 'pressure group' involved are to be congratulated for their persistence. Also, at last, after a long wait, some new signage for The Paddock has arrived which will no doubt please a number of residents.

COMMUNITY SAFETY

RECYCLING

At a recent meeting with Councillors Razia Daniels and Neil Sullivan, the following issues were discussed:



- Damage to grass verges [partly due to other vehicles passing the recycling vehicle as the recycling is sorted at the kerbside]. Please be patient or avoid having to pass the recycling vehicle.
- Debris left after the boxes have been recycled. If it is particularly bad, please report it to CWaC on 0300 123 7026, but if it is only the odd piece, perhaps we should consider picking it up ourselves?
- Residents are reminded to keep their food waste containers in the locked position to deter vermin and foxes [see article below].

SUBURBAN FOXES

In March a new Curzon Park resident was alarmed to see a fox in their garden in the middle of the day, [see



photo] particularly as they have a young child. In the light of recent news in the media, a reminder was sent to CPRA members via email about foxes, and we think it might be useful to repeat the advice for the benefit of all residents. There are mixed feelings about these [wild] animals but the general guidance in dealing with suburban/urban foxes would seem to be:

- Do not feed them as this will encourage them closer to your house. They will feed on vermin such as rats and mice so another good reason not to feed them.
- Backdoors should be kept closed particularly if you are not in that area of the house.
- Rubbish should be securely stored, particularly food, empty food containers [preferably rinsed out] and disposable nappies.
- Foxes generally shy away from humans and larger animals but pets such as rabbits and guinea pigs left outside at night could be vulnerable as could young kittens.
- Foxes will panic if they are trapped in a room or shed or garage so they need to be able to escape.

As one resident pointed out, it is worth bearing in mind that 4 fox attacks on children have been reported in the last ten years while there are 6,000 dog attacks on adults and children, requiring hospital treatment each year [figures from "Number Crunching" in Private Eye].

Update from PCSO Fox:

I would continue to urge all homeowners to lock their doors and windows to prevent opportunistic burglaries, particularly before you go to bed at night. Also remember to put car keys in a safe place, out of sight, and activate any intruder alarm if you have one. Always leave your vehicle locked and secure. These simple precautions are an effective measure to safeguard your home and valuables.

To reduce the chances of becoming a victim, please record serial numbers and other identifying marking on property of value such as mobile phones, laptops and power tools. All serial numbers should then be registered on the immobilise database www.immobolise.com If you contact me on cheshire.pnn.police.uk I will also arrange to visit your address and register any push bikes on the property database. I also encourage residents to take a picture of any high value bikes for their records.

Police Surgeries are held in front of the Post Office on Chester Street, Saltney between 09.00 and 10.15 on the first Saturday of every month (local councillors are also in attendance).
