WALKING GROUPS

Weekend Walking Group

Saturday 12 July - Llandudno

This is a circular walk around the top of the Great Orme with amazing views across to Anglesey and then back down into the town. The walk is about two hours and not difficult, as it is all downhill!

Saturday 2 August - Saughall to Shotton

A generally flat walk along the old course of the River Dee to the historic village of Shotton. Duration approx. 2.5 hours. Refreshments at the Greyhound Inn, Saughall.

Saturday 6 September - Erbistock

A 4.5 mile-long walk starting and ending at The Boat Inn in the ancient village of Erbistock. River and field paths with a few stiles and some uneven ground.

Saturday 4 October - Holywell

This is a historic walk around Holywell and Greenfield Valley, taking in St Winifride's Well and Basingwerk Abbey. The walk will only be about three miles long and will probably take about an hour and a half.

HIGHWAYS & OPEN SPACES

Highway Maintenance to Roads & Footways

Following a meeting with the CWAC Highways Department to discuss and inspect the condition of the roads and footpaths in Curzon Park, we were advised that all roads and footpaths are subject to an annual evaluation and grading process to assess the current condition of the surfaces.

We were informed that residents could report a fault online in the event of a situation which was likely to cause injury/accident e.g. pothole or subsidence etc.

The contact website is www.cheshirewestandchester.gov.uk/highways, click on 'report a fault'. This would be classified as a 'Categorized Defect' and will be dealt with as a matter of urgency.

The 2014 Highway Maintenance programme for Curzon Park is as follows:

- Curzon Park North (from Earlsway to Railway bridge) – new surfacing to carriageway and footway.
- Earlsway generating complaints, therefore under survey this year for potential scheme in 2015
- Curzon Park South generating complaints, therefore under survey for potential scheme in 2015
- Howe Road in poor condition included in potential scheme for 2015
- Mount Pleasant identified for future scheme

 including replacing footway flags to flexible surfacing.

All other roads - no current plans.

Several driveway access areas have already been marked for resurfacing.

Grass Verges

Seasonal mowing is currently operational, but due to further budget cut-backs the frequency of mowing will be seriously affected.

Residents who are looking after their own verge area certainly highlights the inadequacy of the Council operation. Can we encourage more residents to look after their own patch? Would there be any support for a neighbourhood scheme? Let's be honest, the Council grass cutting operation is awful and likely to get worse! And last but not least ...we are still awaiting new 'No Parking on Verges' signs, which have been requested.

Trees in Curzon Park



Readers may have seen the recent Sunday Times article, warning of the "galloping extinction" of the Horse Chestnut tree which are very much part of our Curzon Park landscape.

Experts are recommending 'cutting down' these trees to prevent the spread of disease caused by a combination of pests & diseases, bacterium & fungi which cause branches to fall off.

We are still awaiting some replacement trees and the Council reminded us that, it was expected that local residents would look after and water these young plantations during dry spells.

Bulb Planting



Last year the CPRA received a community grant of £1,000 from credit card company MBNA.

The application requested funding for the newsletter (hopefully everyone will agree that's being used to good effect!), our Christmas event, Carols on the Green, and bulb planting. We have not spent the money on bulbs yet, and would be interested to get any views/advice from residents on what bulbs we should get, and where we should plant them.
