CWAC Local Plan

As many residents will know, the Council's development plan for the period to 2030 envisages some 1400 houses being built on land currently designated as green belt, south of the Westminster Park residential area, north of the A55 southerly bypass and west of the A483. There are potentially serious implications for existing residents of the City, particularly those in Westminster Park who, via their residents' association, have been active in monitoring the progress of the plan and lobbying to ensure their concerns are taken into account. They include issues affecting land drainage, sewerage, schools, shops, roads, health services, etc.

The threat to quality of life in Curzon Park may be less acute, but there is potential for us to be affected in a number of respects, not least by the likely severe increase in the already serious traffic congestion affecting Overleigh Roundabout and Grosvenor Road. So far, the plan has made no attempt to address the issue of traffic and roads.

After initial public consultation in June, the plan has been undergoing a technical review by a government inspector, whose findings are expected to be published in November. There is then expected to be a further opportunity for public involvement before the plan is sent for consideration by the Secretary of State for Communities and Local Government.

Westminster Park Residents' Association have invited CPRA to join them in ensuring that shared concerns are taken into account and adequately addressed, and your management committee has agreed in principle to work with them. HIGHWAYS & OPEN SPACES

Highway maintenance

Resurfacing work on the section of Curzon Park North to the railway bridge was duly completed within the specified time period.

Other highway maintenance projects in Curzon Park scheduled for the current financial year have yet to be started.

Chester Racecourse Company Community Liaison Committee (CRCCLC)

CPRA was represented at this inaugural meeting in August.

The CRCCLC reported that noise levels at the various public events had been within the permitted tolerances (decibel levels). However, some complaints had been received in relation to the Polo events and the CRCCLC agreed to monitor this event more carefully.

The Highways and Open Spaces Group has asked Councillor Daniels to request a place on the CRCCLC.

Planning Application for 13 Curzon Park South

The current application for extensions and redevelopment of the existing Care Home is causing some concern to local residents. This application has been previously withdrawn and although the scheme has been modified, it is generally deemed to be an inappropriate commercial development within a prime residential area of Chester. CPRA will be submitting a 'NO' vote on behalf of members (as mandated at our AGM in May this year) but this does not preclude individual residents from making their own representation should they wish to do so.

Spring Bulb Planting

CPRA volunteers will be in action during the latter part of October (hoping that we have had some rain to soften the ground). Thanks to the Community Grant from MBNA, bulbs have been purchased from Morreys Nurseries (top of Kelsall Hill) and we are grateful to them for their help, advice and generous discount. Planting areas under consideration include: Curzon Park North, Selkirk Road, Carrick Road, Earslway and The Green.

Grosvenor Bridge

Cycling on the footpath over the Grosvenor Bridge is still causing many complaints. Our local PCSO, Chris Fox, has been monitoring this as much as his time will allow. Signing on the bridge is not permitted due to the Listed Status of the bridge. We are grateful to him for his efforts to date and hope that a satisfactory solution can be found soon.

Shropshire Gardens' Visit



Wollerton Old Hall

On a beautiful September morning, nearly 40 residents set off for a visit to Wollerton Old Hall and Hodnet Hall Gardens. Wollerton Old Hall, owned by Lesley and John Jenkins, has three north-south and three east-west vistas, resulting in a number of separate gardens, each one with its own style and ethos. COMMUNITY SAFETY

Update from PCSO Fox



As the dark nights approach, it is important that residents remain security conscious and ensure they take basic security measures. These include locking house and car doors and windows, keeping valuables away from

display, setting alarms and being vigilant for signs of suspicious activity.

Recently, two thefts from motor vehicles were reported around Curzon Park. On both occasions, machinery and tools were taken from the vehicles. These crimes show that someone was active around the area looking for opportunities to steal items from vehicles. If you see anything suspicious, please call and report it on the Police non-emergency number 101.

Bag it, bin it!

Dog faeces can be dangerous, as well as unpleasant – and Toxocariasis (a parasite found in dog faeces) can cause blindness in children.

We often see bags of it left around Curzon Park. Perhaps these 'pet-lovers' think someone will take their mess away. If you see anyone throwing their bag away, suggest they take it home and put it in their own bin. You can also report dog fouling online using the CWAC website. The Clean Neighbourhoods and Environment Act 2005 carries a fine of up to £1000.
