Highways Update from David Miller

On 12 October, CWAC had a Highways meeting. On behalf of CPRA, the following points were highlighted to councillors and authorities in relation to current issues within the area. We're awaiting their response.

- 1. Council's hedgerow and undergrowth encroaching along footpath between 1 Curzon Park North and 3 Curzon Park North. Push chairs and wheelchairs difficult to get past – this has been formally reported twice in the last few months but with no action (one of the ref. nos is: HW215117843)
- 2. Low/overhanging (council) trees along pathways throughout Curzon Park but especially Earlsway and Selkirk Drive – these require pruning so pedestrians/prams/wheelchairs don't have to manoeuvre round them.
- 3. Pathways down Curzon Park North, Curzon Park South, Selkirk Drive, Carrick Road uneven and badly damaged in some areas caused by tree roots.
- **4.** We were advised speeds would be assessed in Curzon Park North and Curzon Park South to identify if the average speed on these roads drop below 24mph. Update still outstanding.
- 5. Increase in speeding traffic along Curzon Park North and Curzon Park South (people using CPS as a rat run to get through the Overleigh traffic lights quicker). Is there any way we can put up a 'watch your speed' LED or get the police to conduct speed checks to enforce drivers to abide by speed restrictions?
- **6.** Private property hedgerows encroaching the public footpaths. Can the council enforce these people to maintain their hedges so as not to hinder pedestrian access (especially those with buggies and wheelchairs)?
- 7. What is CWAC's stance on managing pavement parking? Are they putting recommendations forward under the Traffic Regulations Order (TRO)? If not, why not?
- 8. Road gutters and drains choked up with weeds along Howe Road. Other gutters and drains across Curzon Park also in need of being swept/unblocked
- 9. Flooding occurs in heavy rain on the corner of Curzon Park North and Curzon Park South and also at the end of Hough Green where it joins the Overleigh roundabout. Road surface also poor at the Hough Green/Overleigh junction
- **10.** On-going street light saga in Curzon Park. New LED lights point onto the road and not the paths which pushes walkers to use the road when dark. Issue has been raised on numerous occasions but there's never been a categorical 'yes' to improvements coming or 'no', they're staying as is.
- **11.** Northway at the junction with Earlsway road in need of repair.

Please remember, should you identify any council related issues, these can be reported through the Cheshire West and Chester Council website – www.cheshirewestandchester.gov.uk. The more people who report issues via their web site, the greater the chance of getting things resolved. It's usually a numbers game for getting less urgent issues addressed.
