## ANNUAL GENERAL MEETING 10 JULY 2025

### Our AGM is important because we may need to dissolve CPRA

CPRA is run by a small group of volunteers elected at the AGM. This year three members of the committee come to the end of their term. For CPRA to continue we need people to step forward for the Chair and Secretary roles. Ideally we also need to fill the roles of Highways & Open Spaces Lead and Membership Secretary.

If we don't have residents coming forward then unfortunately we will need to dissolve CPRA. We simply can't operate without filling key roles.

You might be thinking whether having CPRA is helpful (or indeed whether it is needed). We could still run a Facebook page or WhatsApp groups and I know many residents find other social media groups helpful. The main benefits of keeping CPRA are:

1. CPRA can bid for funds from the Council and from other organisations. Examples include bulbs, social events, some running costs, and assets such as the marquee.
2. Having a Residents' Association can be helpful in liaising with the Council and the police. This is amplified through CPRA's membership of CRAG (Chester Residents' Associations Group) which has played an important role in several improvements in the city over the last few years.
3. It can coordinate social events easily for example many events on The Green.
4. The newsletter and email are helpful ways of keeping all residents up to date.

The Cheshire West and Chester Council's Tree Officer has decided that we need to wait until October 2025, which is the next planting season. This is to allow for underground cable scans and the consultation with Cadent Gas to be completed.
